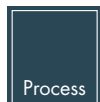

Identifying falsified résumés

"The applicant claimed he attended Canterbury University. BackCheck's database indicated that there were two school's by this name. One was a legitimate university and the other was a known diploma mill. BackCheck contacted the client for the location of the school to confirm which school the applicant was referring to. The applicant then sent in a letter meant to prove that the school was accredited. BackCheck was able to confirm that the school was not a legitimate institution. We then proceeded to verify two other credentials provided by the applicant which also turned out to be false claims."
